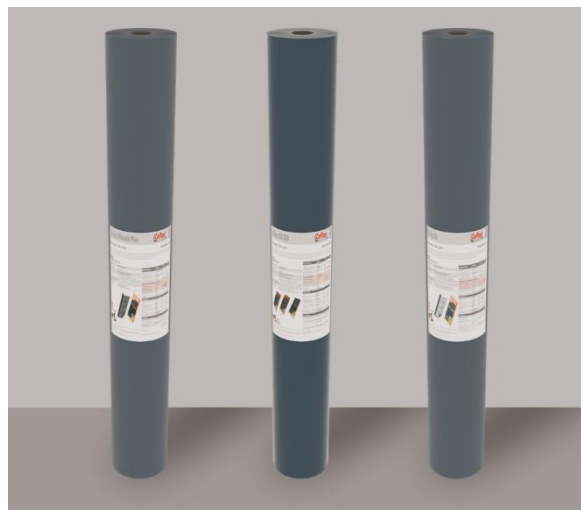
3. Product information

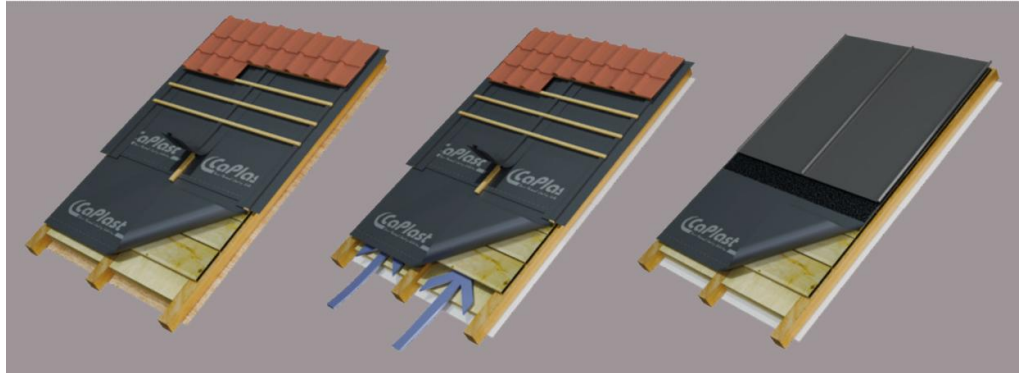

CaTop UD 360 is an underlay membrane with a special, durable, monolithic polyurethane (TPU) functional layer on both sides, as well as a tear-resistant non-woven fabric polyester in the centre. The membrane is an energy-efficient, diffusion-open, premium underlay membrane that can be welded either hot or cold. It has a three-layer structure consisting of two durable, monolithic poly- urethane functional layers and a centrally positioned non-woven fabric. Designed as a premium product, the membrane is intended for

use as a wind-, rain- and waterproof underlay for a range of applications (UDB-eA). Its fast reaction time during welding and flexibility enable efficient and easy processing. CaTop UD 360 is particularly suitable for use on flat roofs that fall below the standard roof slope. It can be used for extended applications in accordance with Classes 1 and 2 of the ZVDH regulations, as well as Type 2 in Austria and for extraordinary loads in Switzerland. This enables a diffusion-open roof construction up to the minimum roof slope of the roofing material.

A CaPlast membrane typically consists of two layers of thermoplastic nonwoven fabric with a functional film sandwiched between them, responsible for waterproofing and vapor permeability.

All membranes produced consist of a bottom nonwoven, a top nonwoven and a functional film produced beforehand. Depending on the process used, the top nonwoven can be extruded directly before the lamination process or a previously produced nonwoven is used. The bonding of the individual layers can be done by thermal lamination alone or by the addition of powdered or liquid adhesive, and the high temperature accelerates the bonding of the layers. There are no other differences in the manufacturing process of the different types of membranes.

The production of the upper nonwoven fabric is done as follows: thermopolymers, flame retardant, UV stabilizer, and in some cases, color masterbatch (pigment) are loaded into dispensers. The granulate mixture, in the appropriate proportions, is transferred to an intermediate tank and then to an extruder. The granulate mixture is plasticized in a single-screw extruder, after which threads are extruded through screens and dies. The extruded material is then bonded with the functional film and additional nonwoven fabric (the bottom layer, either purchased externally or extruded in a separate process) using heated calenders at the appropriate temperatures. The functional film and the bottom nonwoven fabric are supplied to calenders by a series of unwinders and spreading rollers.

On one line, the product is transported through a printing module. The resulting membrane is cut into the appropriate lengths before being wound onto spools. The obtained Jumbo Rolls are typically transported to the second production facility - Now Contec, where they are further processed into smaller rolls, are properly labelled, additional adhesive strips are applied, and prepared for dispatch according to orders.

The packaging of CaPlast membranes consists of:

- Wooden pallets
- Cardboard
- Cardboard cores
- Paper
- Stretch film
- Strapping tape

All materials used are recyclable and can be reused or disposed of in accordance with local waste disposal regulations.

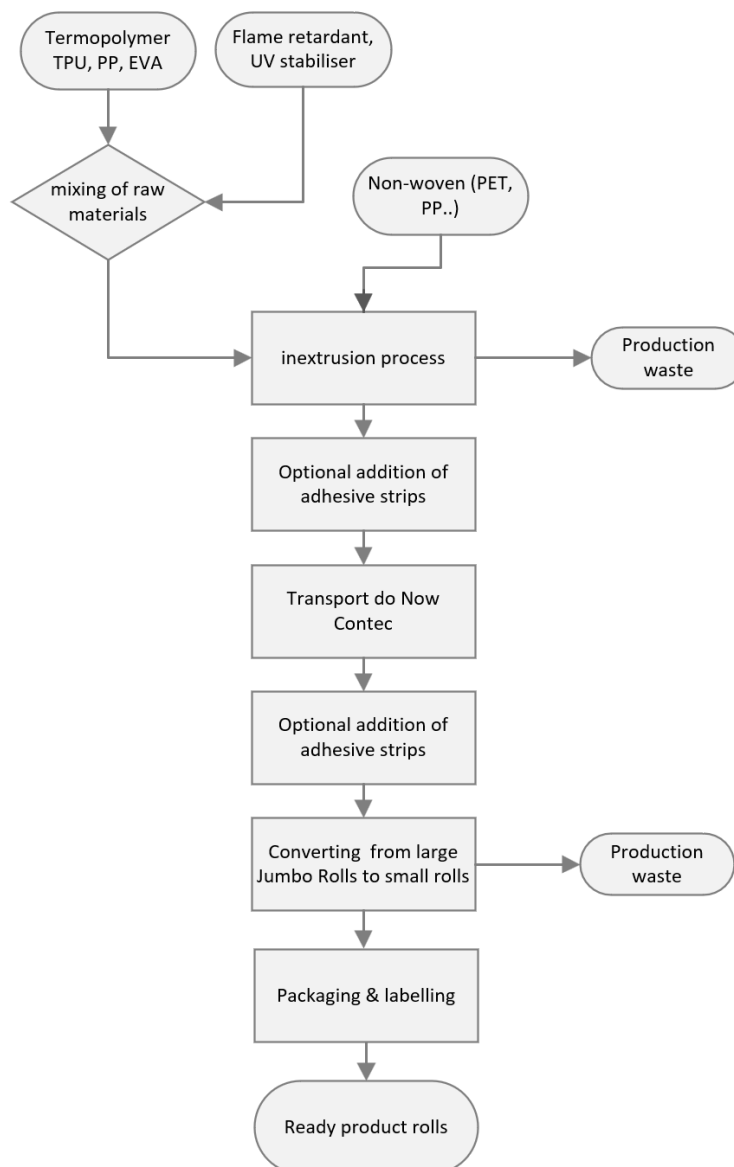


Figure 1 The production flowchart

Due to the biogenic carbon content of more than 5% by mass in packaging, it is necessary to take this figure into account in the LCA. The assessment of carbon content was based on the types of materials used for packaging. No biogenic carbon was identified in the other materials, in particular the raw materials used for the membranes. A summary of the materials making up the packaging and the biogenic carbon content is presented below.

The carbon content of cardboard and wood was assessed using data from the Ecoinvent database.

according to the information currently available to us, all membranes and related accessories manufactured and distributed by CaPlast do not contain any restricted, prohibited and SVHC substances. They do not release any dangerous substances during the use stage.

4. Life Cycle Assessment Information

Declared Unit

The declared unit is defined as square meter (1 m²) of membrane. The grammage varies from 200 g/m² to 380 g/m² depending on the product.

Reference Service Life

Due to the lack of a specific PCR relating strictly to the membranes, the Reference Service Life is not specified, although it can be assumed that their lifetime may be analogous to that of the buildings and structures into which the membranes have been incorporated. It can be assumed that membranes are regarded as having 50 years Reference Service Life (RLS) independent of their material - the same service life as the building.

System and its boundaries

As the boundaries of the system, the Cradle to Grave was adopted.

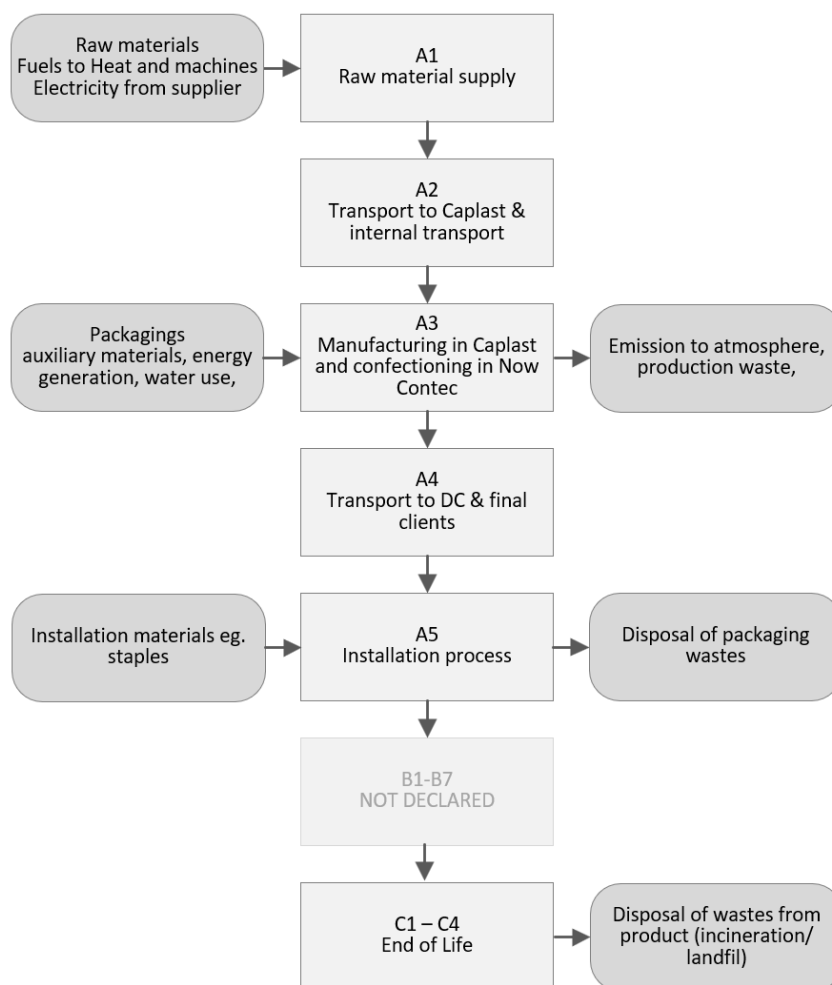


Figure 2 System boundaries

A1	The calculations used a model for individual raw materials. In particular, the manufacture of plastics and additives necessary for the production of membranes. The Ecoinvent database and SimaPro software were used. In the case of composite materials, e.g. plastic+additives, the calculation separates the material into the basic raw materials according to the percentage of the individual components. The weight of raw materials was based on the gross BOM according to the Caplast accounting and settlement system. The calculations took into account the packaging of incoming raw materials, i.e. their weight and types of materials (bags, octabins, big bags). The generation of electricity not produced by the EPD Owner is included in A1, as also the production of fuels consumed by the EPD Owner for thermal or mechanical energy. Transport processes within the supply chain (excluding transport from direct suppliers) is included in A1 if they are not based on specific data but on average data (usually included in generic datasets). Production of auxiliary materials is not included in A1. Water is included in A1 if it is a constituting and purchased input. The emission factor of the electricity for 2024 was 0,1073 kgCO ₂ e/kWh.
A2	The calculations used a model of transport from sources to manufacturing plant of materials based on actual logistic data from Caplast IT system. A2 includes all transport processes from the direct suppliers, including transport of constituting materials, packaging materials of the product and auxiliary materials of the manufacturing. Internal transport of laminates between the laminate production site and

	the site of manufacture and final packaging of the end product was also taken into account. Internal transport is included in A2.
A3	The calculations used actual data on consumption of electricity, fuels, water, and took into account only emissions to the environment, internal transport and handling of production waste; this module also includes raw materials for final packaging. A3 includes the upstream production processes in the supply chain of auxiliary materials and product packaging. Additionally, all natural resources directly extracted and all emissions directly generated by manufacturing process is included in A3. Handling of manufacturing waste up to the end-of-waste state (e.g. transport, processing, treatment, disposal) is included in A3.

C3	The scenario of zero impact was considered; we do not anticipate that used membranes will be specially selected for full energy recovery as secondary fuels. For this reason, in accordance with the standard of section D.3.3 of Module C, it has been assumed that used membranes will be subjected to thermal waste conversion in a plant with a capacity of less than 60%, which is subject to demonstration in Module C4.

Assumptions

The list of assumptions are as follows:

The list of assumptions in the LCA study are as follows:

- Module C2: Distance to disposal site after demolition is assumed to be 100 km. In module C, transport of 100 km was used according to COMMISSION RECOMMENDATION (EU) 2021/2279 of 15 December 2021 and also according to verified EPDs of other manufacturers, e.g. declaration number 2021M10140, registration number EPDITALY0140 - Air, wind and water barrier membranes and Vapor control layers - valid to 18/05/2026.
- Due to the fact that the membranes are mainly sold to European customers, it was assumed that the waste scenario record links to ecoinvent incineration and landfill waste treatment processes – the recycling waste treatment processes linked to were created by PRé Sustainability. This datasheet is valid for the municipal solid waste of EU27. Europe without Switzerland incineration and landfill processes were used. Data for European countries were retrieved from the Eurostat table packaging wastes by waste management operation, extracted in 27 October 2021.
- While potential benefits from energy recovery (module A5 and C4) were calculated and European grid mix values were used as a basis (Europe without Switzerland market)
- Assumptions for module A5 regarding the consumption of metal clips and adhesive tape, including the material from which the tape is made. Due to the lack of detailed data on the composition of the tape to be used in the installation of the membranes, non-woven polyester was assumed as the main component of the tape.
- Mass of packaging waste and the waste, dismantled membrane equals the amount of input materials

Cut-off

The cut-off rule was applied to the following input streams, which in terms of factors such as mass; energy requirements and environmental significance are irrelevant for the quantification of environmental impacts. Data excluded from the LCA study due to the cut-off are listed in the table

The check of the cut-off rules was done on the basis of expert judgement based on experience with similar product systems and a partial sensitivity analysis, which assessed how the 'cut-off' input or output affected the final results. For individual products, the sum of the masses of substances that were excluded from the cut-off calculations did not exceed 1%, so it can be assumed that the resulting LCIA calculations are meaningful.

Allocation principles

Since measurements of **electricity, heat, water, fuel consumption and generated waste** are recorded for the entire plant without dividing it by the types of membranes produced, an allocation of the aforementioned utilities by membranes weight was applied.

5. LCA results

Below are tables with the calculation results related to the declared unit, i.e. one square meter (1 m²), of each membrane. A list of indicators and their descriptions can be found earlier in this paper.

The abbreviations used in the tables refer to parameters describing resource use:

Data Quality

The LCA analysis used data that ensures authoritativeness and eliminates bias and uncertainty as much as possible. The best quality data available was used. Data quality was characterized by both quantitative and qualitative aspects.

The characterization of data quality addressed the following issues:

- (a) temporal scope: the age of the data and the minimum period over which the data should be collected;
- (b) geographic coverage: the geographic area from which unit process data should be collected to meet the purpose of the LCA study;
- (c) technology coverage: a specific technology or combination of technologies;
- (d) precision: a measure of the variability of each expressed data value (e.g., variance);

To assess the quality of the data, the DQR index was used, understood as an evaluation of the quality criteria of the dataset on the basis of technological, geographic, time-related representativeness and precision. The DQR index was estimated in accordance with the European Commission Recommendation EU 2021/2279 according to the formula.

$$DQR = \frac{TeR + GeR + TiR + P}{4}$$

Where the respective symbols stand for:

TeR - Technological Representativeness

GeR - Geographical Representativeness

TiR - Time-related Representativeness

P – Precision

In order to determine the values of the indicators characterising the quality of the data, the descriptive parameter matrix used in SimPro software was used. This matrix coincides with the table presented in Annex E of the ISO 15804+A2:2019/AC:2021 standard, with the exception that it still contains an additional criterion related to the Precision parameter. Quantitative assessment of data quality has been carried out on the basis

of the contribution of the individual footprint components listed below, which together account for 90% of the total footprint.
